

TOWN OF MARATHON, NEW YORK
LOCAL LAW NO. 2 OF THE YEAR 2025

A Local Law amending the Town of Marathon Zoning Ordinance and Zoning Map.

Be it enacted by the Town Board of the Town of Marathon as follows:

Section 1. Enactment and Title

The Town of Marathon Zoning Ordinance be and hereby is amended by this Local Law as follows:

- A. The following parcels situate on Route 11 are hereby zoned and designated Industrial District as provided in Article VI of the Town of Marathon Zoning Ordinance adopted September 17, 1970, and amended February 11, 1992, subject to all regulations created and established relative to said District:

- B. The Town Zoning Map, referred to in Article II Section B of the Town Zoning Ordinance, is hereby amended to reflect the rezoning of the five tax parcels set forth herein.

Section 2. Severability

If any part or provision of this Local Law or the application thereof to any person or circumstance be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part of provision or application directly involved in the controversy in which such judgment shall have been rendered and shall not affect or impair the validity of the remainder of this Local Law or the application thereof to together persons or circumstances, and the Town Board of the Town of Marathon hereby declares that it would have passed this Local Law or the remainder thereof has such invalid application of invalid provision been apparent.

Section 3. Findings

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

Section 4. Effective Date

This Local Law shall take effect immediately upon the filing in the Office of the New York Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.
